ORDER:

Whereas, in the G.O.2nd read above, orders were issued formulating the “Andhra Pradesh Real Estate (Regulation and Development) Rules, 2017”. Subsequently, an amendment was issued to Rule 18(2) of “Andhra Pradesh Real Estate (Regulation and Development) Rules, 2017” vide G.O.3rd read above, enhancing the strength of existing Three (3) whole time members to Five (5) whole time members.

2. And whereas, in the G.O. 4th read above, orders were issued, re-constituting the Selection Committee under Rule 34(1) of Andhra Pradesh Real Estate (Regulation and Development) Rules, 2017 for selection of Chairperson of the Appellate Tribunal and other three whole time Members (a Judicial member, one Town Planning Technical and one Administrative Member), consisting of:-

(i)	Hon’ble Sri Justice C. Praveen Kumar, Acting Chief Justice of Andhra Pradesh	:	Chairman
(ii)	Principal Secretary or Secretary to the Government, Municipal Administration & Urban Development Department	:	Member
(iii)	Secretary to the Government, Law Department	:	Member

3. And whereas, in the G.O. 5th read above, orders were issued, constituting the Search Committee to suggest a panel of names possessing requisite qualification and experience and suitable for being considered for filling up the two (2) vacancies in the category of Members available in the first instance and also for the other posts in "Real Estate Regulatory Authority" as and when vacancies arise, due to completion of term or resignation of existing body.

4. In the letter 6th read above, it was informed that, Sri Justice C. Praveen Kumar, Hon'ble the Acting Chief Justice, High Court of Andhra Pradesh has given consent of His Lordship for taking up of selection process for filling up the posts of Chairperson and Members in "Real Estate Regulatory Authority", as and when vacancies arise.

5. In view of the consent received in the ref. 6th read above, Government, hereby to extend the purview of the Selection Committee constituted vide G.O. 4th read above, to carry out the selection process for filling up the post of Chairperson and Members in "Real Estate Regulatory Authority" also as and when vacancies arise.

6. The Selection Committee shall make its recommendations to the Government with the eligible persons in the form of a panel of not more than two persons in order of preference separately for each vacancy or posts.
