ORDER:

Whereas, in the reference 1st read above, the Government of India enacted "The Real Estate (Regulation and Development) Act, 2016" and published in the Extraordinary Gazette No.16 of 2016, dated 25th March, 2016.

2. And whereas, in the G.O., 2nd read above, the "Real Estate (Regulation and Development) Rules, 2017" were issued. The Rule-18 of Real Estate (Regulation and Development) Rules, 2017, prescribes the procedure for constitution of "Real Estate Regulatory Authority" and the manner of selection of Chairperson and Members of the Authority.

3. According to Rule 18(5) of AP Real Estate (Regulation and Development) Rules, 2017, Government have constituted the Search Committee vide G.O., 4th read above, under the chairmanship of Sri Neerabh Kumar Prasad, IAS, CCLA & Special Chief Secretary and Sri R.Karikal Valaven, IAS, Special Chief Secretary & Sri Gopal Krishna Dwivedi, IAS, Principal Secretary, as members to suggest a panel of names for filling up the posts of Chairperson and Members in Real Estate Regulatory Authority, as and when vacancy arises.

4. Now, Government have decided to re-constitute the Search Committee. Accordingly, the Government in exercise of powers conferred under rule 18(5) of AP Real Estate (Regulation and Development) Rules, 2017, hereby re-constitute the Search Committee with the following officers:-
